## **MINUTES OF ANTI-RAGGING COMMITTEE MEETING & ACTION TAKEN REPORT**

- 1) Ragging in all its forms is totally banned in Saveetha Engineering College and including in its departments, constituent units, all its premises whether located within the campus or outside and in all means of transportation of students whether public or private.
- 2) The institution shall take strict action including but not limited to criminal proceeding and/or cancellation of admission against those found guilty of ragging and/or of abetting ragging and the burden of proof shall hereby lie on the perpetrator of alleged ragging and not on the victim.
- 3) An offence of Ragging may be charged either on a written complaint by the affected or on independent finding of the Anti-Ragging Squad during their regular visits.
- 4) The Institution is bound by the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009.
- 5) CCTV Cameras are installed in Vital points of Students Gathering with proper monitoring.
- 6) Two separate forms are provided on College Website for students to register their Complaints against any kind of Discrimination / Ragging or Grievances related to anything.
- 7) The Videos / Short films given by UGC have been displayed on Campus Television network to be played 24x7 and displayed on College Website and Web Portal to spread awareness of Anti-Ragging.
- 8) Anti-Ragging warning is published in the Institution's Prospectus & Information Brochure.
- 9) Regular meetings are conducted with Day scholars and Hostellers separately to gather any early signs of ragging and to give them confidence and courage to raise their voice against any kind of violence.
- 10) Anti-Ragging Posters with phone numbers are created and displayed prominently within the campus. (Also attached herewith for your reference)
- 11) Professional Counsellors from Department of Psychology, Saveetha Medical College visit our campus twice every week or anytime during need to counsel our students.



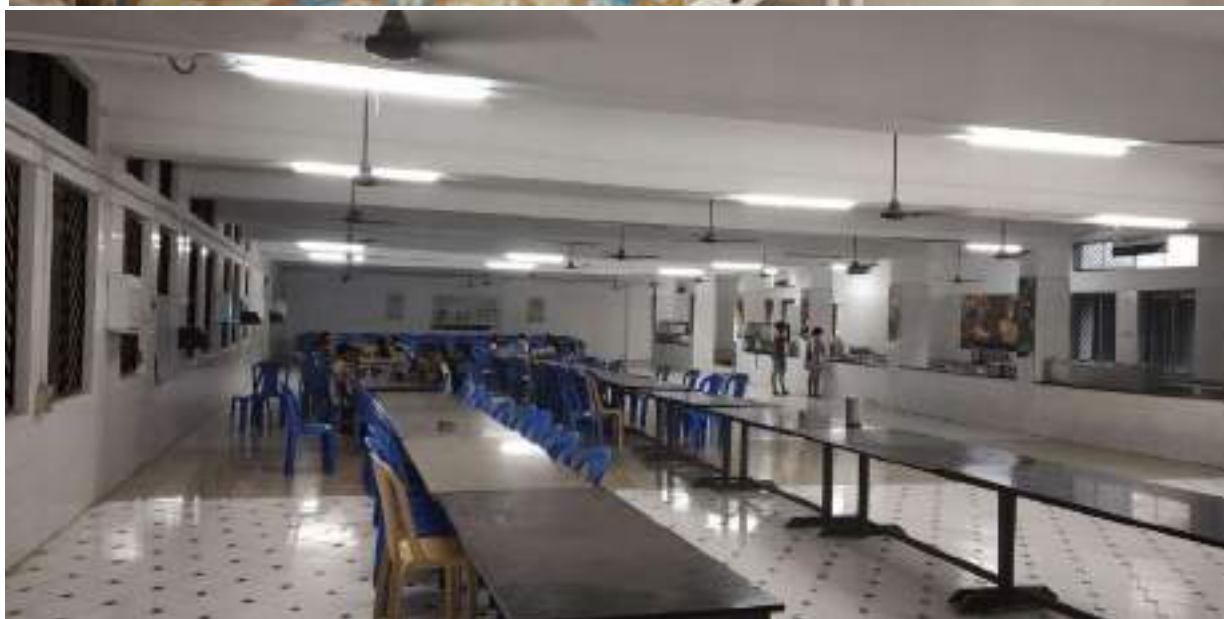
